

**NOTICE OF OPEN MEETING  
REGARDING CONSIDERATION TO APPROVE A TAX ABATEMENT AGREEMENT  
BETWEEN THE CITY OF ROSENBERG, TEXAS,  
AND BIOTICS RESEARCH CORPORATION**

Notice is hereby given that the City Council of Rosenberg, Texas, will hold an Open Meeting on Tuesday, April 20, 2021, at 6:30 p.m. in the City Council Chamber, City Hall, 2110 4<sup>th</sup> Street, Rosenberg, Texas, regarding consideration to approve a tax abatement agreement between the City of Rosenberg, Texas, and Biotics Research Corporation, being both the property owner and the applicant for the tax abatement agreement, located in Rosenberg Business Park, in Rosenberg Reinvestment Zone No. 27, comprised of 8.539 acres, more or less, more specifically described as follows:

**BEING 8.539 ACRES (371,966 SQUARE FEET) OF LAND, BEING A PORTION OF THE 183.369 ACRE TRACT DESCRIBED IN THE DEED FROM WINDMEADOWS INVESTORS, LTD. TO ROSENBERG BUSINESS PARK, LTD., RECORDED UNDER FILE NO. 2013-092132, IN THE OFFICIAL PUBLIC RECORDS OF FORT BEND COUNTY, TEXAS, IN THE S.B. PENTECOST SURVEY, A-378, FORT BEND COUNTY, TEXAS, AND MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS WITH BEARINGS BASED ON THE NORTHEASTERLY RIGHT-OF-WAY LINE OF BUSINESS PARK DRIVE (80-FEET WIDE) AS SHOWN ON BUSINESS PARK DRIVE AND INNOVATION COURT STREET DEDICATION, THE PLAT THEREOF RECORDED IN FILE NUMBER 2015-0094 IN THE OFFICIAL PUBLIC RECORDS OF REAL PROPERTY OF FORT BEND COUNTY, TEXAS.**

Pursuant to the terms of Reinvestment Zone No. 27, improvements consisting of new, expanded and modernized buildings and structures, including fixed machinery and equipment, which will be constructed, erected, or placed on the property within the zone, will be eligible to receive commercial-industrial tax abatement, which will go into effect in Tax Year 2023. The estimated cost of the improvements are \$8,000,000.

All persons desiring to address Council regarding the adoption of the tax abatement agreement will be given the opportunity to do so. The City Council will, in addition, receive written comments if timely filed with the City Secretary no later than 5:30 p.m. on April 20, 2021, prior to commencement of the open meeting.
