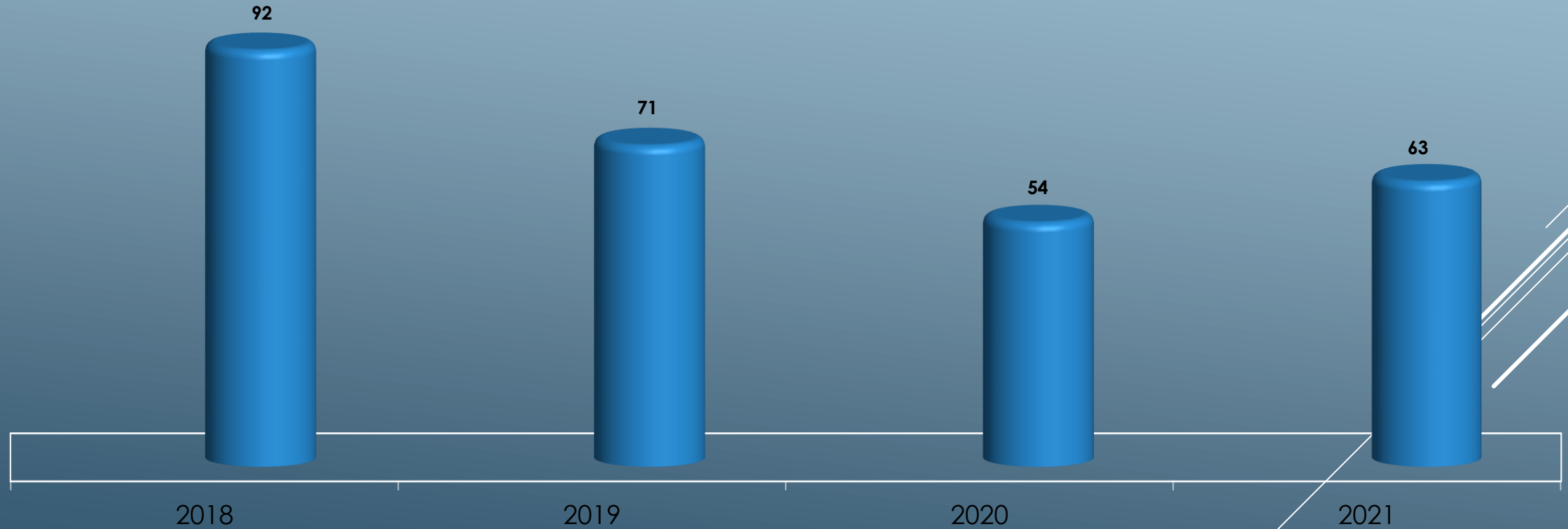
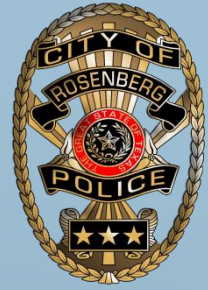
# 4 year comparison GROUP A for the month of May



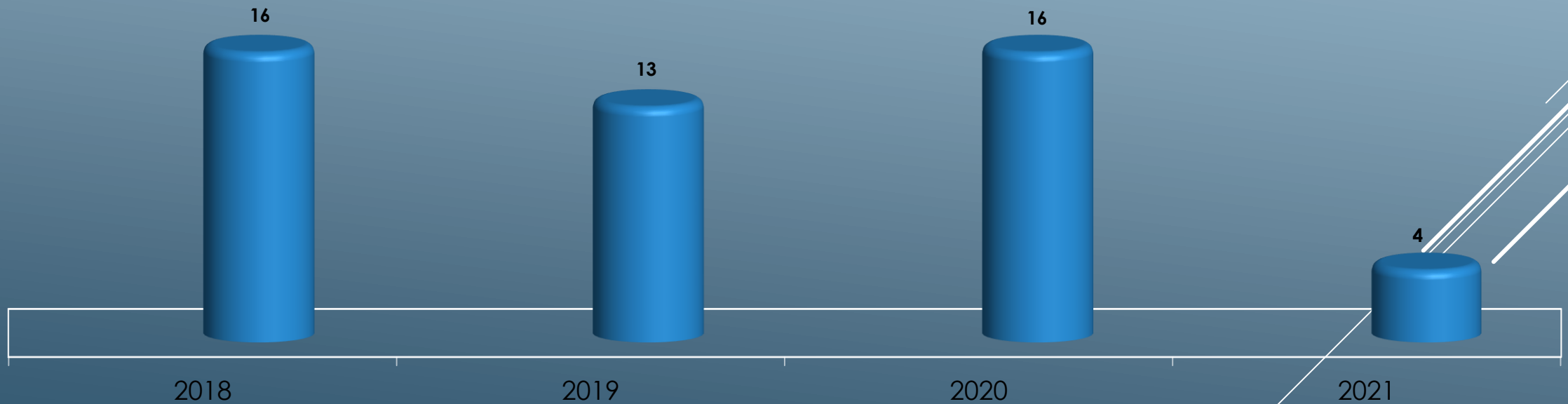
# 4 year comparison Property crimes for the month of May



# 4 year comparison Person crimes for the month of May



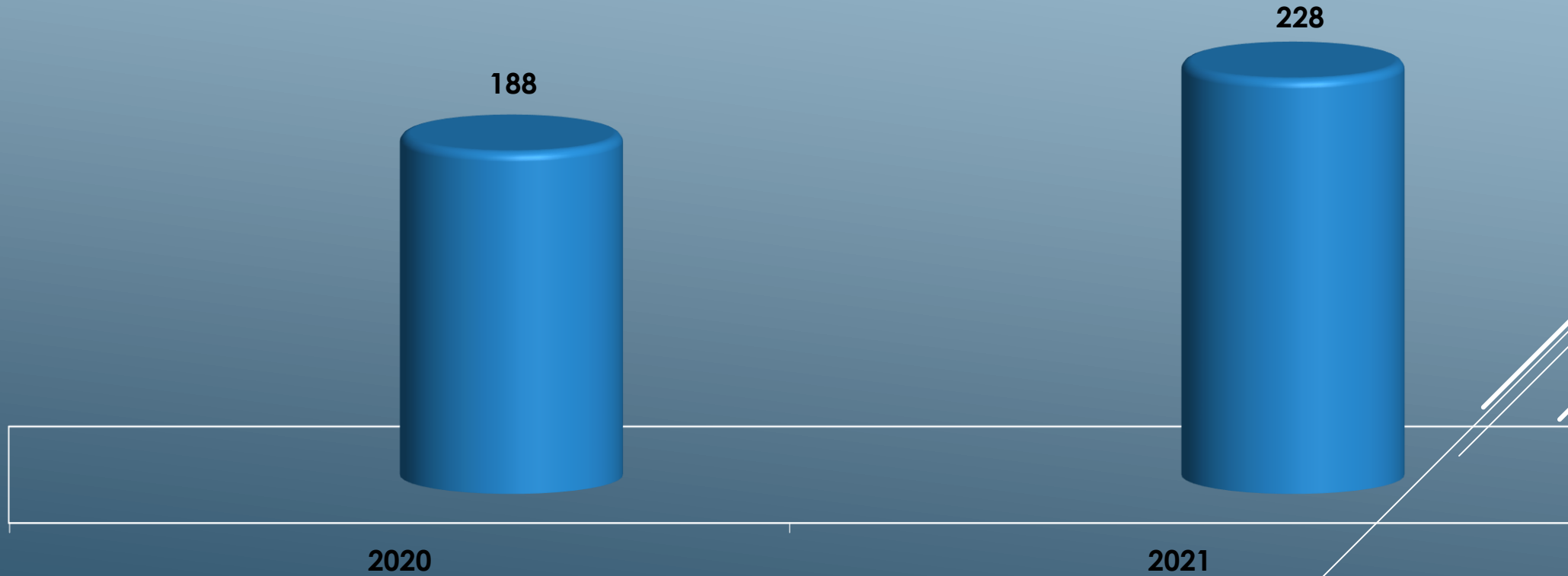
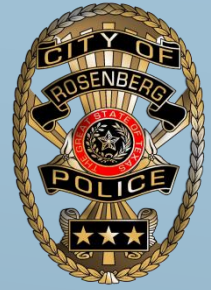
# 4 year comparison Violent crimes for the month of May

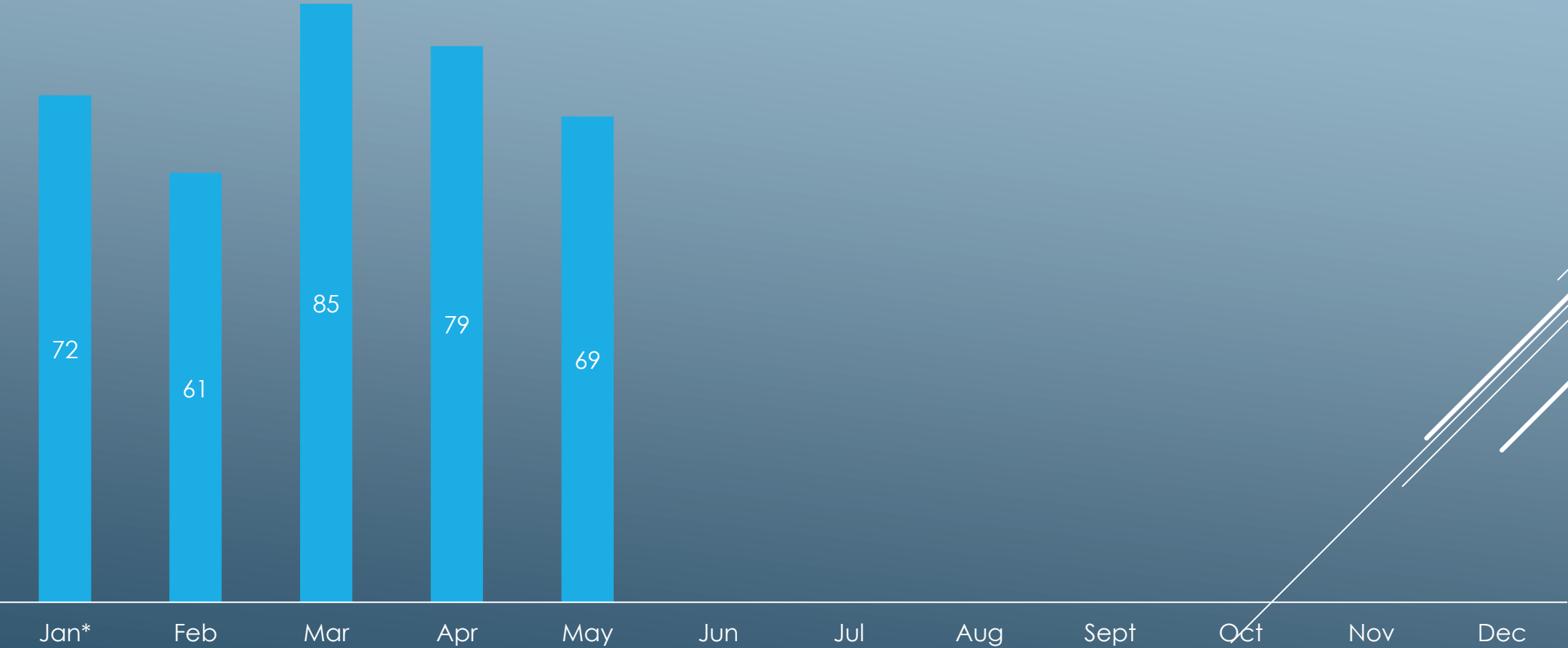
