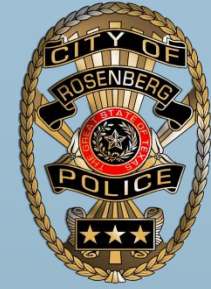
PROPERTY CRIMES



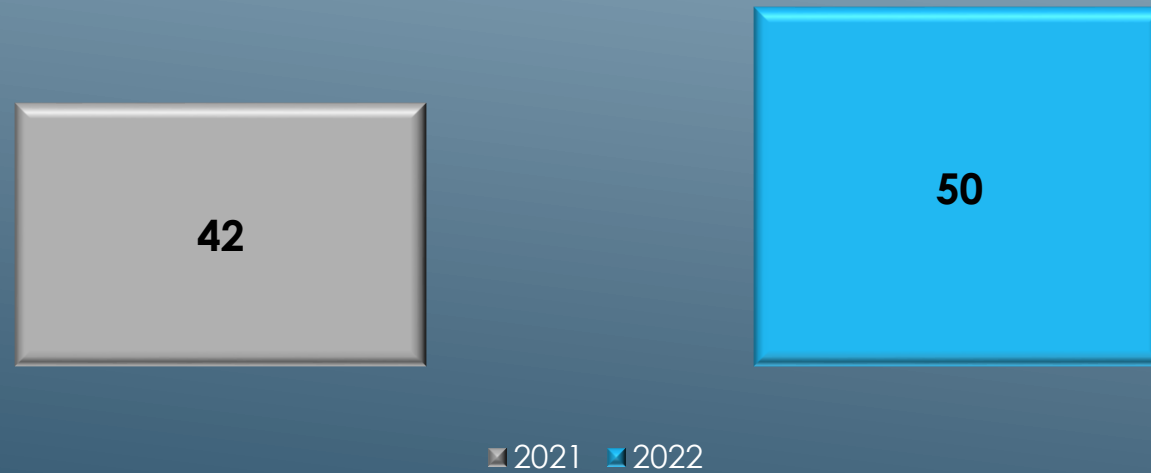
February 2021 compared to February 2022



PERSON CRIMES

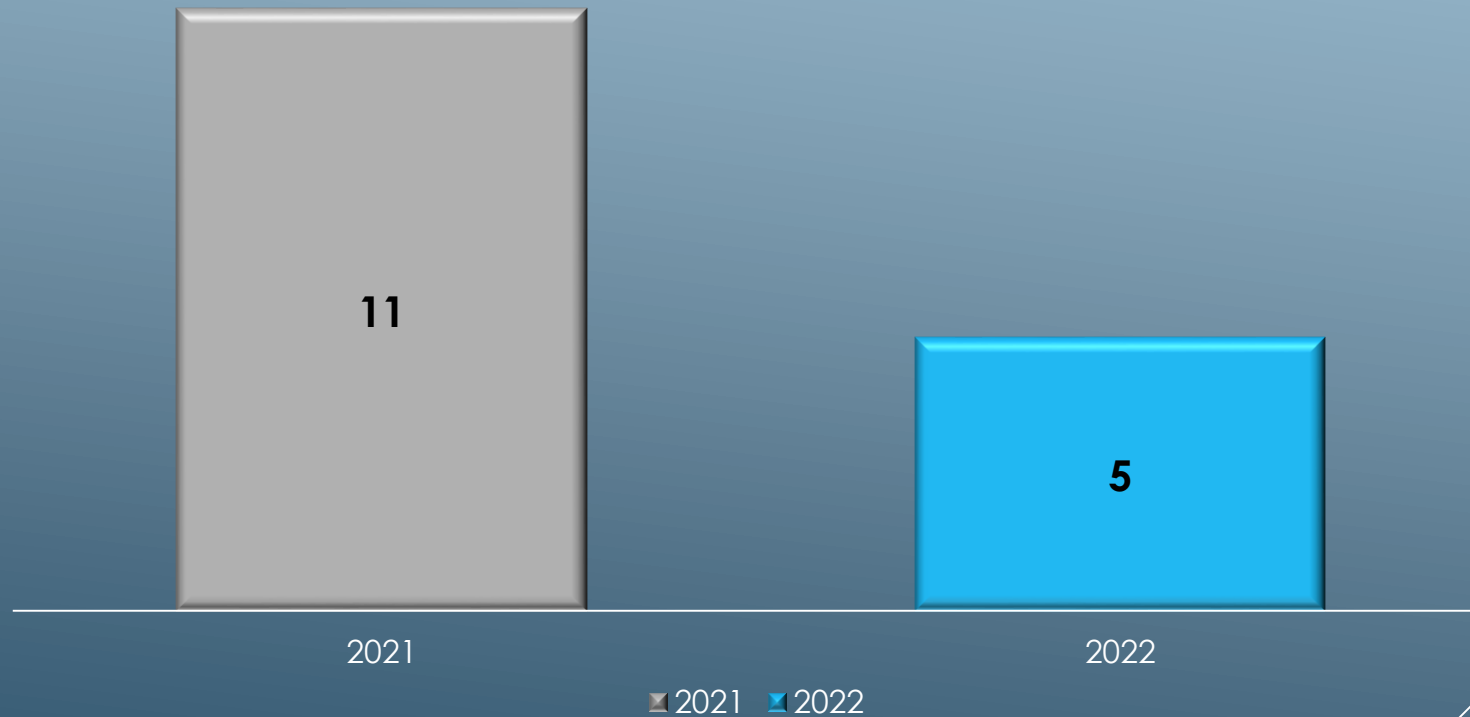


February 2021 compared to February 2022



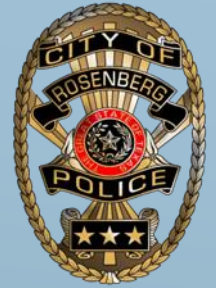
VIOLENT CRIME

January 2021 compared to January 2022

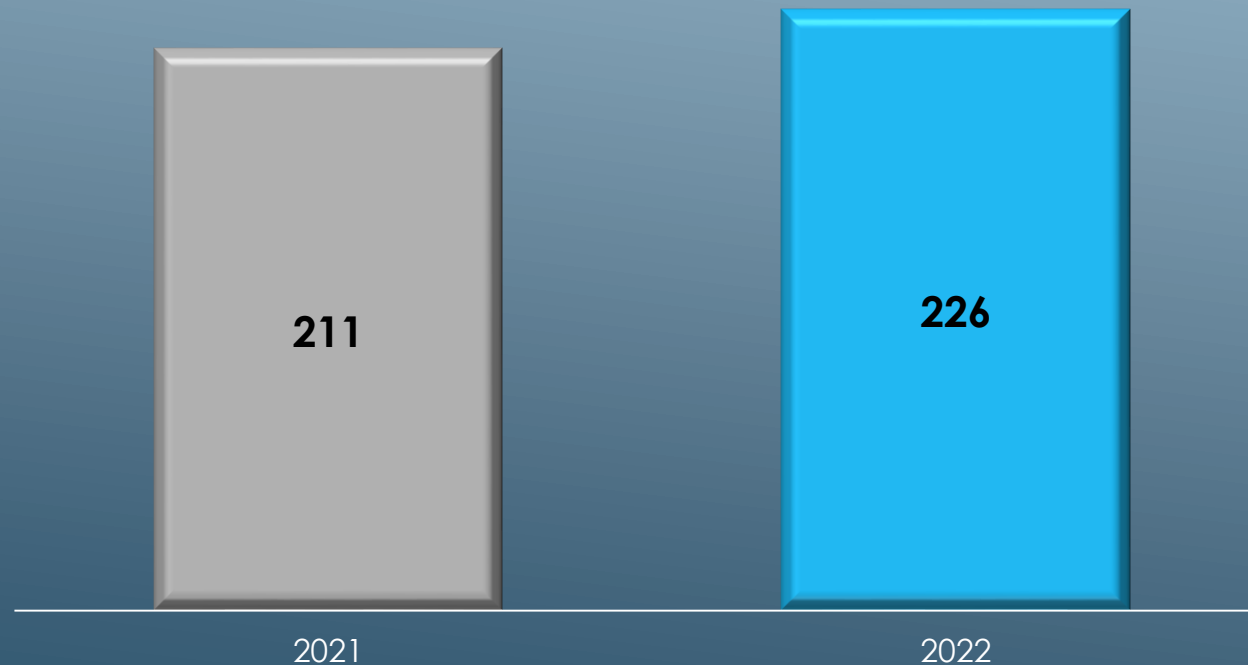

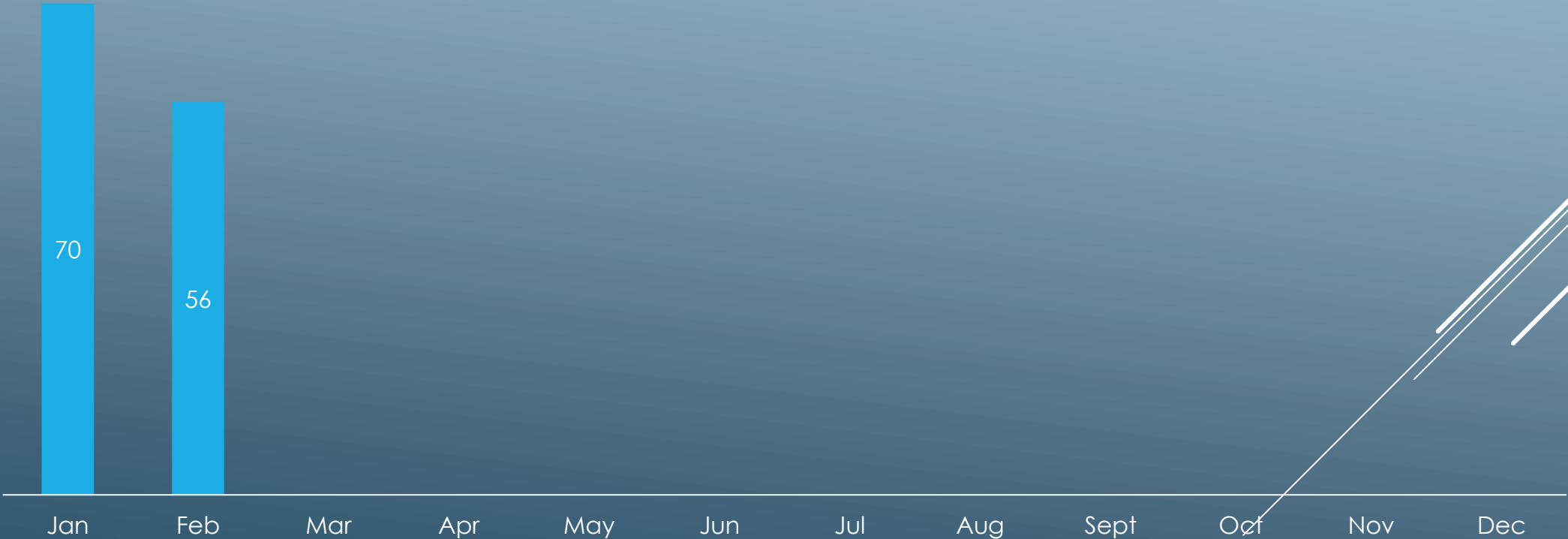
