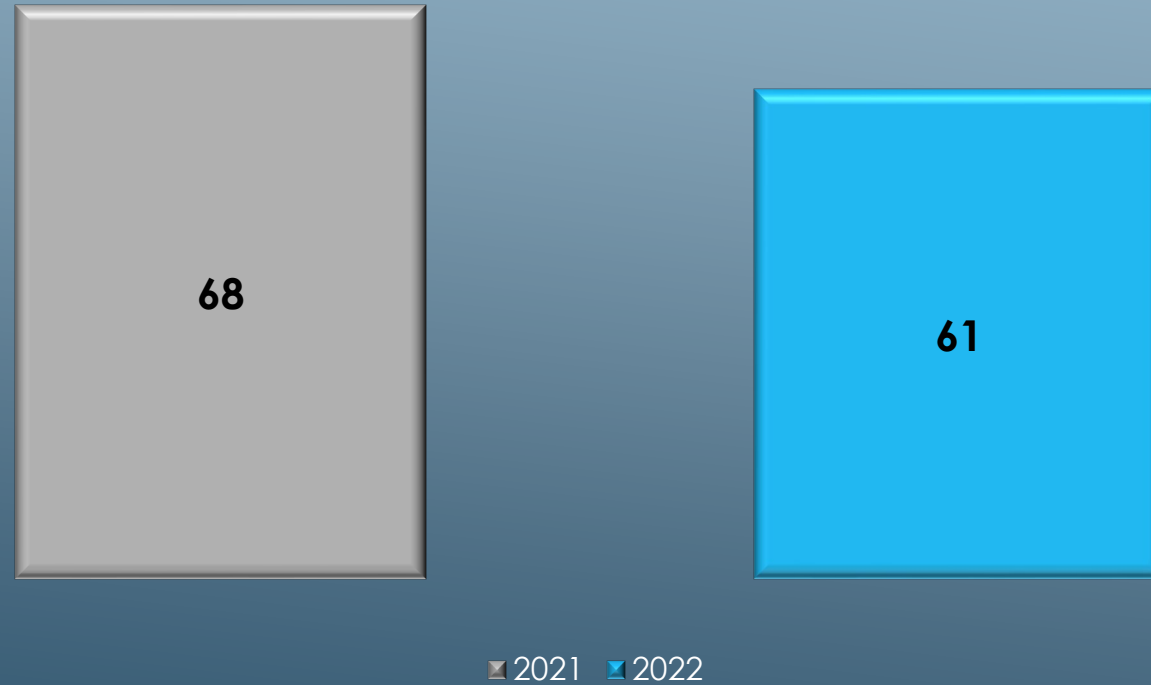

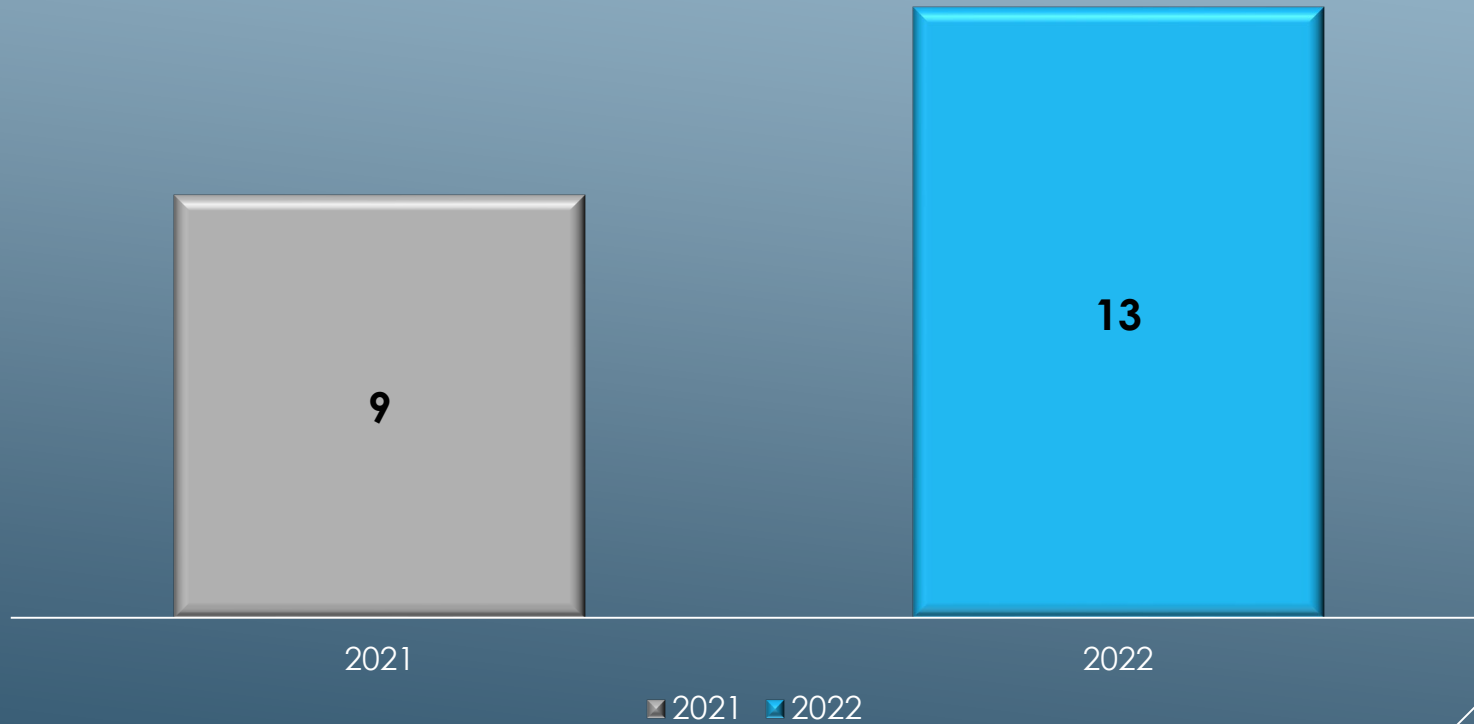

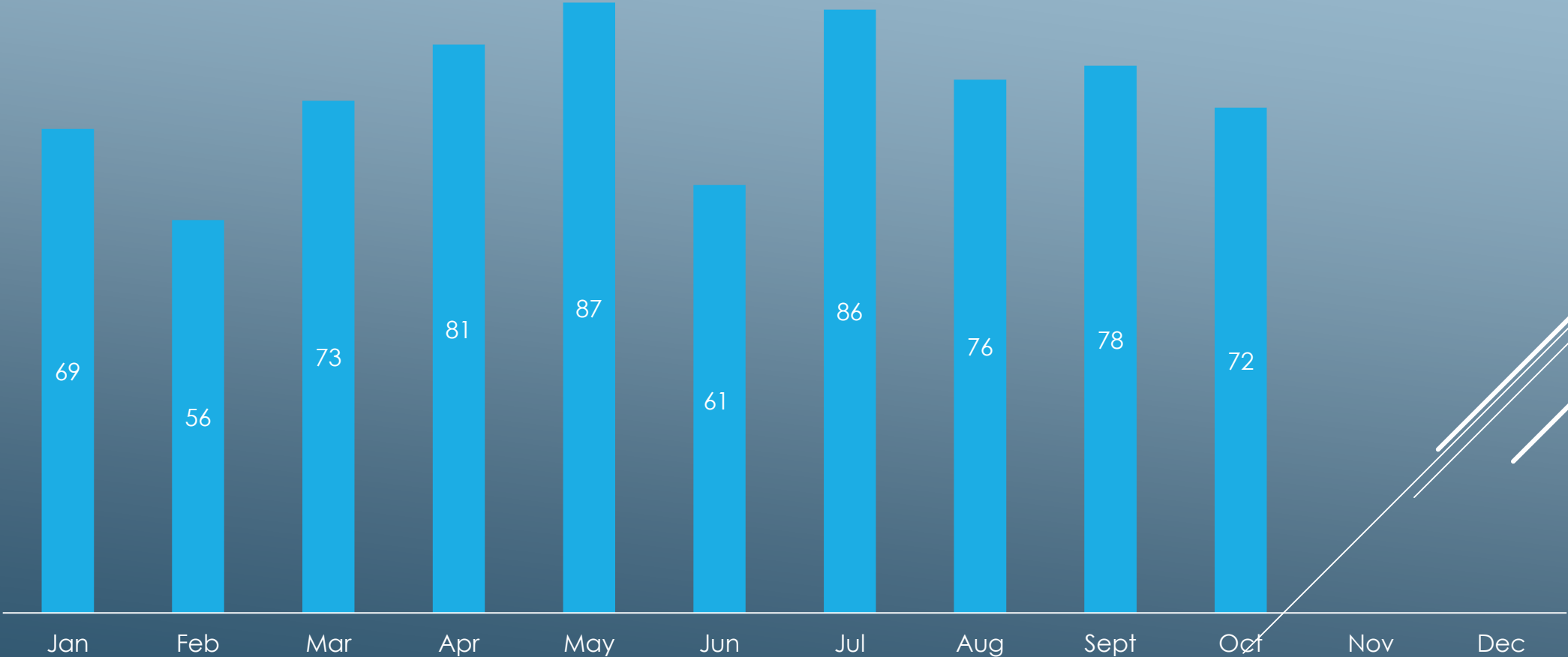

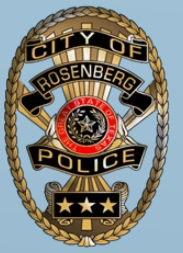
# COMMUNITY RELATIONS DIVISION
